Please now find two call documents for research funding as follows:

- 1) **Master's Scholarships** This is to fund students (paid a maintenance grant/student stipend) for 2 years. We are proposing that the students are recruited from an eligible Small Island Developing State, and study for a Master's at an Irish HEI with a placement of at least 25% based in the relevant SIDS. Main query for you is the list of eligible SIDS (Annex 2).
- 2) **Fellowships** This is to fund a fellow (paid a salary) for 3 years. We are proposing that the fellows are recruited from an eligible Small Island Developing State, and work as a researcher at an Irish HEI with a placement of at least 25% based in the relevant SIDS. Again main query for you is the list of eligible SIDS (Annex 2).

I am working on the final call document for projects, and will be sending this to you tomorrow.

I hope that you are well.

I met with Niall and Fiona yesterday to discuss the launch of the remaining calls under the Our Shared Ocean Programme for 2022, with the split of calls as outlined in the table below. We would like to give the SIDS time to connect with their Irish counterparts to discuss their research and develop a working relationship, and therefore would like to postpone one of the large project award calls (Projects - 18 to 36 Months) until 2023.
